### 2. JURISDICTION:

- a. The above-mentioned OPEN meeting has been authorised by Motorcycling NSW Limited who has issued the Motorcycling Australia Permit Number TBA and is open to holders of current Motorcycling Australia National Competition Licence.
- b. Motorcycling Australia One Event Licence (available with entry)
- c. The meeting will be held in accordance with the current General Competition Rules (GCR's), these Supplementary Regulations, the By-Laws of Motorcycling NSW and any final instructions.

BY ENTERING THIS MEETING ALL PARTIES AGREE TO COMPLY WITH THESE RULES, REGULATIONS, BY-LAWS AND INSTRUCTIONS.

### 3. ENTRIES:

- 3.1 Entries online only via RIDERNET All entries must be electronic (no paper entries) Only entries received on line via Ridernet will be accepted.
- 3.2 There will be 3 levels of entry fees
- 3.3 <u>EARLY BIRD ENTRIES</u> Entries open forthwith and close midnight Monday 12 days prior to each event <u>STANDARD ENTRIES</u> Entries open forthwith and close midnight Tuesday 4 days prior to each event <u>LATE ENTRIES</u> Late entries will be accepted up to midnight Thursday 2 days prior to each event <u>Any entry/payment received after close of standard entries will incur late entry fee of \$20</u>
- 3.4 In the case of postponement or abandonment of the meeting a \$15.00 adminstration fee will apply.
- 3.5 Riders must notify the race secretary by 5pm on the Thursday 2 days prior to each event of any changes to their entry in order to be entitled to any refund refund policy will apply see 6.4
- 3.6 THE RETURN OF ENTRY FEES FOR ANY RIDER WITHDRAWING FROM THE MEETING IS OUTLINED IN THE REFUND POLICY 6.4
- 3.7 NO ENTRIES ON THE DAY

#### 4. INSURANCE:

- 4.1 National Capital Benefits Scheme provides basic cover for death and permanent disability.
- 4.2 Personal Accident is the responsibility of the individual and Ambulance Insurance is compulsory for licensees
- 4.3 IT IS STRONGLY RECOMMENDED THAT COMPETITORS GIVE DUE CONSIDERATION TO TAKING OUT SUCH INSURANCE COVER.

#### 5. MEDICAL SERVICES:

Suitable First Aid Service will be available on each day from start of sighting lap to completion of Competition



### 6. ENTRY FEE:

6.1 Electronic Timing will be used for this meeting. Licence / Junior Log books will be collected at sign on and returned at the conclusion of the meeting when transponder returned. Failure to return transponder will incur a replacement cost to a maximum of \$550.00 (plus postage & insurance) payable to the promoter.

Transponder brackets will not be hired – transponder brackets will be available for sale at a cost of \$15.00

- 6.3 ENTRY FEES: can be paid by Credit Card at time of entry Ridernet will charge a small fee.
  Final Instructions and rider entry list (list of riders who have entered that round) will be posted on the
  Facebook page: NSW Off Road and on MNSW website. It is the responsibility of each rider to obtain and
  read the final instructions and to check their class & rider number

#### 6.4 **REFUNDS**

- a) Riders withdrawing in writing before close of early bird entries will be entitled to a refund , less a \$20 administration fee.
- b) Riders withdrawing in writing before 5pm Friday 8days before event will be entitled to a refund , less a \$30 administration fee
- c) Riders withdrawing in writing after 5pm Friday 8 days before event and up to close of standard entries will be entitled to a refund less \$50.00 senior and \$40.00 junior administration fee
- d) Riders withdrawing in writing after close standard entries and prior to 5pm on the Thursday, 2 days prior to the event will receive a refund, less \$80.00 senior and \$60.00 junior administration fee.
- e) Riders withdrawing from the event after 5pm on the Thursday 2 days prior to the event WILL NOT be entitled to any refund.
- f) Should the event be cancelled by the Steward due to "force majeure" (e.g. inclement weather) then the following shall apply; Riders who did not ride or enter the track will receive their entry fee less 40% administration fee. Riders who competed will not be entitled to any refund.
- g) All withdrawal requests MUST be in writing to the Race Secretary

#### **Age Requirement:**

JUNIORS & SENIORS: the age will be determined by the age the rider is at the  $1^{st}$  January in the year of racing J1 & JM classes – minimum age will be riders age on date of event.

#### 8. AWARDS AND PRIZEMONEY:



- 8.1 A trophy will be awarded to the 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> placed rider in each class per event.
- 8.2 Presentation of event awards will be made as soon as possible at the close of competition
- 8.3 Attendance at presentation forms part of your contract to ride, upon entry
- 8.4 Riders not attending Presentation will not be entitled to any awards
- 8.5 Championships Awards shall be made at the end of year presentation. For all Championship classes; 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> place getters will be awarded a State Championship Medallion. The NSW Enduro Committee will recognize all classes with an award at the NSW Enduro Presentation. (A rider must enter 75% rounded down) of the total number of eligible Championship rounds to qualify for the Championship. Tied Championship points at end of series Juniors will be awarded equal placings; Senior as per GCR's.
- 8.6 Championship Points: Scoring will be as per current GCR's. Championship points will be accumulated overall Rounds that attain minimum number of entries for that class, with a minimum number of 6 rounds for each class to constitute a championship class. All riders who attend the event will earn a minimum of 5 championship points (including DNF riders)
- 8.7 <u>JM Class –</u> Championship points will be accumulated over all rounds that attain minimum number of entries for that class, with a minimum number of 2 rounds to constitute a championship class.
- 8.8 Championship points will be electronic by MA Licence.

### 9. ENTRIES TO CONSTITUTE A CLASS:

For all Championship classes, the number of entries received at the closing date will determine if the number is sufficient to constitute a championship. If there are insufficient numbers, that class will not be run as a championship for that round / event.

- 9.1 Ten (10) entries will be required to constitute all senior classes except Women's and Vintage Class Eight (8) entries will be required to constitute all junior classes except Girls, J1 and JM Six (6) entries will be required to constitute Women's, Vintage, Girls J1 and JM Classes Minimum numbers based on a minimum of 4 rounds to constitute a championship class, except JM class which will be based on a minimum of 2 rounds to constitute a championship class.
- 9.2 Should there be insufficient entries in any class of competition, the decision to run or cancel the class, or to combine events and re-distribute any awards and/or prize money, will be at the discretion of the promoter, subject to Motorcycling NSW approval.
- 9.3 JM Class & J1 Class may be combined if insufficient entries are received in either or both classes

#### 10. RACE FORMAT:

Round 1: Stadium Enduro X Round 2: Stadium Enduro X

Round 3: Sprint Round 4: Sprint

Round 5: Cross Country / Sprint Round 6: Sprint / Cross Country

Round 7: Sprint
Round 9: Sprint
Round 10: Sprint
Round 11: Sprint

The Sprint is held along the lines of an Enduro special test. Riders complete as many heats of the course as decided by the promoter (aiming for a minimum of 4). The number of heats is to be confirmed by the promoter no later than the end of the third heat. Times will be cumulative. In the end, the rider with the least elapsed time for the class will be the winner. Timing will be done with transponders (manual backup may be used where deemed necessary by the Clerk of Course) to be considered a finisher, riders must start all heats and complete a minimum of 2/3rds of the total heats of the winning rider. If a rider DNF's a heat they shall be awarded a time of no less than 50% slower than the slowest rider in their class for that heat.

All riders will be escorted on one sighting lap prior to their 1<sup>st</sup> race. No riders may enter the course without permission of the Clerk of Course after racing has started.

\*\*\* The sighting lap is not compulsory – it is the rider's responsibility to enter the sighting lap within 3 minutes of the sighting lap starting or entry to sighting lap may be denied \*\*\*



10.2 **The Cross Country** will be approximately 8 - 25 klms in length as measured by the Clerk of Course.

All riders will ride for a determined minimum time – Riding times for each class will be notified to Rider in the final instructions. Riders may be notified of the remaining laps, at the Clerk of Course discretion. The chequered flag will be presented to the lead rider. There will be a mandatory fuel stop for all junior riders (all junior rider must take on fuel at some stage during the race.) In order for a rider to be classed as a finisher they must:

a) complete 50% of the total number of laps of the winning rider **or** have continuity of racing as determine by the Clerk of Course and b) cross the finish line after the lead rider.

Penalties will be issued by the Clerk of Course to any rider who a) leaves the course;

b) receives fuel anywhere, except in the designated fuel control area; c) junior riders who do not have mandatory fuel stop.

All riders will be escorted on one sighting lap prior to their race. Riders may walk the course on the day prior to the event, at a time notified in the final instruction. No riders may enter the course without the permission of the Clerk of Course after racing has started.

- \*\*\* The sighting lap is not compulsory it is the rider's responsibility to enter the sighting lap within 3 minutes of the sighting lap starting or entry to sighting lap may be denied \*\*\*
- 10.3 <u>The Enduro</u> will be held in accordance with GCR regulations. Time Schedules will be issued at the event. All <u>Juniors</u> MUST always carry their time card with them.
- 10.4 The Clerk of Course may alter, with permission of the Steward, racing format should safety or environmental conditions warrant such change. Riders shall be notified at a rider briefing or via noticeboard of any changes
- 10.5 Championship classes will take precedence over non-championship classes
- 10.6 No riding other than in the event is permitted
- 10.7 Results will remain "Provisional" until ratified and confirmed by Motorcycling NSW

### 11. MACHINES AND RIDERS:

- 11.1 Machines entered in the competition must successfully passes a machine examination prior to taking part in practice or racing. A decal will be placed on the front number plate of each machine to indicate that it has been successfully examined.
  - Rounds 7 & 8 and 11 & 12 will have self-scrutineering available
  - All machines entered must comply with the current GCR's for for Enduro and reliability trials and the Series Regulations. All motorcycles MUST be fitted with a **removable fuel cap (i.e. no fast fuelers)**
- 11.2 Helmets must be presented at scrutineering. Eligibility checks can take place at any time during the meeting.
- 11.3 Machines suffering accident damage in practice or race sessions must be re-examined before participating again
- 11.4 Multiple entry of the one machine in the same class of competition is not permitted (except 11.5)
- 11.5 Each rider may have scrutineered a 2<sup>nd</sup> motorcycle 2<sup>nd</sup> motorcycle must be Scrutineered during the allotted scrutineering time (i.e. with 1<sup>st</sup> bike) \*\*\* NB 2<sup>nd</sup> motorcycle may be used according to 11.6, 11.7 & 11.8
- 11.6 CROSS COUNTRY ONLY: Change of bike rule: A rider may only change bikes prior to the beginning of racing Permission of the Clerk of Course for mechanical faults only and must remain within the capacity of the class entered. The motorcycle must be scrutineered. A change of bike form must be completed and handed to the Clerk of Course or Race Secretary prior to the start of racing.
- 11.7 SPRINT FORMAT ONLY: Change of bike rule: At any time during the event, either permission of the Clerk of Course, a rider may either ride the 2<sup>nd</sup> bike they scrutineered or borrow a bike from another rider which has been entered in and scrutineered for the event (bike must be of the same class capacity even if same class). A change of bike form must be completed and handed to the Clerk of Course or Race Secretary 5 minutes prior (a form must be submitted for every bike change) Racing shall not be delayed in this instance ENDURO FORMAT ONLY: Change of Bike Rule: A rider may only change motorcycles prior to the start of each round.
- 11.7 Noise &/or Fuel Testing may be carried out at any time during this meeting.

#### 12. RIDING NUMBERS:

#### RIDING NUMBERS MUST BE WITHIN THE SEQUENCE OF THE CLASS ENTERED (SEE 7 – CLASSES)



- 12.1 Competitors will be allocated their Motorcycling NSW Registered Riding Number. Riders who do not have a registered number need to request a preferred riding number on their entry the Race Secretary will notify and rider whose preferred number clashed with a registered number at the event
- 12.2 All number plates and numbers on all machines MUST comply with the current GCR's
  ANY BIKE THAT DOES NOT HAVE THEIR NUMBER CLEARLY DISPLAYED ON ALL 3 NUMBER PLATES WILL BE
  ABLE TO PURCHASE NUMBERS FOR \$25.00 Electrical tape and /or texta will not be permitted Any refusals will deny rider entry without refund

#### 13. GRID POSITIONS:

**Sprint Format:** Starting will be in a seeded combined class order with individuals starting approximately 15 – 30 seconds apart. Start positions in the first heat after a cross country will be based on the fastest lap time of the cross-country round. Start positions in the first heat of rounds where a cross country has not preceded will be based on the that rounds/ events previous cumulative/ heat times (fastest first)

<u>Cross Country Format:</u> Starting will be combined class order with each grid starting one minute apart. The Clerk of the Course reserves the right to seed riders into the start order for the purpose of safety.

<u>Enduro Format:</u> Starting will be in seeded combined class order with individuals starting 2-3 per minute as determined by the Clerk of Course. Start positions will be determined by the Clerk of Course.

\*\* The Clerk of Course reserves the right to seed any riders at any time before or during the event. \*\*

### 14. <u>RIDERS BRIEFING:</u>

One rider briefing per event shall be held, unless otherwise notified by the Clerk of Course A horn will sound as a 4 minute to start signal for riders briefing

All competitors <u>MUST</u> attend the riders briefing if competitors under the age 18 years must be accompanied by a parent / guardian.

Rider's Briefing is a NON-Smoking Area

At riders briefing there will be a random roll call, any rider not present will be fined or otherwise at the direction of the MA Steward

#### 15. DRUG AND OR ALCOHOL TESTING:

By order of Motorcycling NSW, random drug &/or alcohol testing of participants (i.e. officials, competitors, mechanics, pit crew and any other person associated with the control, direction and operation of the competition) may take place prior to, or at any time during this meeting.

For the purposes of Drug and Alcohol testing, the commencement of the meeting will be deemed to be 7.00am Saturday and Sunday with the competition of the meeting for the participant being when all racing is completed.

#### 16. CODE OF CONDUCT:

All competitors, officials, parents and support persons are reminded of the Motorcycling Australia - CODE OF CONDUCT (as stipulated in the GCR's) which is a guide to appropriate behavior at all motorcycle race meetings. This CODE OF CONDUCT applies to this meeting and shall be enforced.

Riders are reminded that they are responsible for their support persons at all times.

#### 17. TIMETABLE:

The Timetable will be detailed in the final instructions

Track Availability: Will be notified to riders in the final instructions.

#### **18. CIRCUIT DESCRIPTION:**

All courses comprise part natural terrain grass track circuit (or similar) and part of the surrounding bushland. The course shall be clearly marked with "gates", arrows and tape. The total course length will be 1 lap.

Riders must stay on the "intent of the course "at all times. A rider should not reply on bunting to follow the course. Shortcutting the course will not be allowed and doing so may result in exclusion from the event.

Sprint format: (Approx. 8km) 1 heat - 1 lap

<u>Cross Country format:</u> Approx. 8km – 25km as measured by Clerk of Course

### 19. STARTS:



<u>Sprint Format:</u> Riders will be self – starting at 15-30 second intervals (as determined by the Clerk of Course) marked on a clock. There shall be no countdown other than this to the start time. Riders must cross the start line within 5 seconds or the starter will manually start the rider. Tailgating of the start line will incur a penalty as determined by the Clerk of Course.

<u>Cross Country Format:</u> Riders will start in a mass grid with combined classes starting 1 minute apart. Riders will be started by flag with no countdown. Riders will start on the bike dead engine. Riders may have both hands on the handle bars to start.

Riders will be given one-minute warm up followed by a one-minute shutdown as notification of one minute to start.

\*\*\* The Clerk of Course may combine any cross-country races with the permission of the Steward \*\*\*

### 20. RACING: (also see 10 – Race Format)

- 20.1 Racing will be started at the scheduled time unless otherwise directed by the Clerk of Course please check final instructions
- 20.2 Support persons / mechanics must not enter the racing area, including the start area unless authorized to do so, by the Clerk of Course for the purpose of:
  - a) Pushing a competitor's machine, except Enduro; or
  - b) Attending to the accident, damaged machine of the relevant competitor; or

#### **21. NOISE:**

All machines must comply with the requirements of the 2021 GCR's

Noise testing may be carried out at any time

The Clerk of Course or Noise Control Officials (Noise Tester) may refer any bike for noise testing

No Bike will be permitted onto the track if it exceeds noise limits. Racing will not be delayed for any rider who must affect repair for noise control prior to reentering the track. I.e.: there will be no "make up" heats or compensation allowances.

#### 22. REFUELLING:

All refueling is to be carried out in the designated refueling area. No refueling outside this area. Riders <u>must dismount</u> prior to refueling. Engine must be turned off during refueling. Enviro Mats must always be used whilst refueling.

All motorcycles must be fitted with a removable cap (no fast fueler caps)

### 23. ENVIRONMENT:

As per 2021 GCR's Environmental Mats must measure 1m x 1.6m and are required to be used by all riders, Support persons and service crews. Mats must be used when replenishing all oils and fluids – e.g. engine oils, gearbox oil, fuel, coolant and chain oil.

The use of plastic, cardboard or non – rubber backed carpet will not be acceptable. Mats will be available at a cost of \$15.00 each.

Tear offs and tear off covers will NOT be permitted

NO rubbish whatsoever is allowed to be left on the ground at any time during the event. All rubbish must be disposed of in the bins provided. If bins are full, rubbish must be taken from the event by the rider and / or their service crew.

<u>WASHING OF MOTORCYCLES</u> – Subject to council restrictions – Each promoter may allocate a place and time for motorcycles to be washed down at each event. Service Crews must supply their own water. Motorcycles must not be washed outside the allocated areas / time or on surrounding toads. Riders will receive information at riders briefing or in the Final Instructions.

#### 24. GST

Income is excepted from tax under subdivision 50A of the income Tax Assessment ACT 1997 and therefore the Promoter does not need to quote an ABN and you do not need to withhold tax. For the purpose of GST, the Entry form will become the Tax Invoice

#### 25. CAMPING REGULATIONS

- 1) Directions issued by the camping officials MUST be adhered to by all persons
- 2) Between the hours of 7am & 4pm Saturday and 7am & 2pm Sunday there is to be NO pushbikes, NO smoking (there will be a designated smoking area) NO alcohol and NO open footwear (i.e. closed shoes must be worn).
- 3) There is a 7pm curfew on all persons under the age of 18. After 7pm all persons under the age 18 MUST always be in the company of their parent or legal guardian
- 4) There is 9pm noise. No noise what so ever after 9pm, including but not limited to generators, bikes and loud voices.
- 5) All campers are to report any problems to the camping official. Photo and Video evidence would be appreciated.
- 6) Any person found to be breaching the camping regulations shall be evicted from the camp site, refused camping at all other venues and may have a penalty imposed up to exclusion. Adult riders are reminded they are responsible for their family and service persons.
- 7) Open fires in the camp area will be restricted and will be advised, to suit weather conditions, on the day or in the Final Instructions.

- "Indemnitees" means and includes the persons, organizations and bodies corporate whose names appear in
