1. **ANNOUNCEMENT:**

The City of Penrith Motorcycle Club, hereafter called the PROMOTER will conduct NSW Classic and Post Classic Championship at the Nepean Raceway, on Saturday 5th & Sunday 6th August 2023.

JURISDICTION: 2.

- The above-mentioned 2023 NSW Classic and Post Classic Dirt Track Championship meeting has been authorized by 2.1. Motorcycling NSW Limited who has issued the Motorcycling Australia Permit Number PERMIT NUMBER and is open to holders of current Motorcycling Australia National Competition Licenses.
- Day Licenses available will be available. 2.2.
- The meeting will be held in accordance with the current General Competition Rules (GCR's), these Supplementary 2.3. Regulations, the By-Laws of Motorcycling NSW and any final instructions. BY ENTERING THIS MEETING ALL PARTIES AGREE TO COMPLY WITH THESE RULES, REGULATIONS, BY-LAWS AND INSTRUCTIONS.

3. **ENTRIES:**

- Entries open forthwith and close 11pm Thursday 20th July 2023. 3.1
- 3.2 In the case of postponement or abandonment of the meeting, all or any part of the entry fee may be retained by the promoter, if such retention is approved by Motorcycling NSW.
- Only entries received via RIDERNET that are accompanied by the correct fee will be accepted. 3.3
- NOTE: LATE ENTRIES MAY BE ACCEPTED OR REJECTED AT THE DISCRETION OF THE RACE SECRETARY, AFTER 3.4 CONSULTATION WITH THE RACE COMMITTEE OR CLUB EXECUTIVE COMMITTEE. AND THE RETURN OF ENTRY FEES FOR ANY RIDER WITHDRAWING FROM THE MEETING IS AT THE DISCRETION OF THE PROMOTER.

4. INSURANCE:



- 4.1 National Capital Benefits Scheme provides basic cover for death and permanent disability.
- 4.2 Personal Accident and Ambulance Insurance is the responsibility of the individual.
- 4.3 IT IS STRONGLY RECOMMENDED THAT COMPETITORS GIVE DUE CONSIDERATION TO TAKING OUT SUCH INSURANCE COVER.

5. MEDICAL SERVICES:

Medical will be provided by Safe for Work from 9:30am until 4pm each day.

6. <u>ENTRY FEE:</u>

- 6.1 Entry fee will be \$120.00 including transponder, with \$20 per extra class
- 6.2 Payment to be made via Ridernet only.
- 6.3 Please include a correct email address for confirmation of entry and any final instructions. Final instructions will be sent to the email on the registration form and posted on City of Penrith MCC Facebook page.

7. ENTRY PASSES:

There will be no passes issued. Entry will be a tax-deductible donation of \$10.00 per vehicle for the two days payable at the gate for the nominated charity, Newborn and Pediatric Emergency Transport Services (NETS) – Moving intensive care for kids.

9. AWARDS AND PRIZEMONEY:

Motorcycling NSW Championship medallions for 1st, 2ndand 3rd place will be awarded for each championship class. City of Penrith Motorcycle club will award trophies for 1st, 2ndand 3rd place for each class.

10. ENTRIES TO CONSTITUTE A CLASS:

10.1 For all Championship classes, the number of entries received at the closing date will determine if the number is sufficient to constitute a championship. The closing date for entries will not be extended.

To constitute a class, the number of contestants entered and competing in each class shall be 10 or more starters for solo classes, 6 or more for sidecar and 6 or more for women which actually participate in practice, qualifying or races.

10.2 Should there be insufficient entries in any class of competition, the decision to run or cancel the class, or to combine events and re-distribute any awards and/or prize money, will be at the discretion of the promoter, subject to Motorcycling NSW approval.

11. RACE FORMAT:

Format where there are more than 12 entries per class.

- a) Three qualifying heats of three laps.
- b) One repechage of four laps.
- c) One final of four laps.

<u>Heats and Final</u>

The number of heat positions must not exceed 12.

The right to compete in the final will be filled by:

- a) The 10 competitors accumulating the highest number of points during the course of heats,
- b) The first two placing of the repechage.
 - Competitors who finish in 11 to 22nd inclusive during the heats will contest the repechage.

Solo format where there are 12 or less entries per class.

The championship comprises five races of three laps.

Points accumulated by each competitor in the five races will determine the Championship placing.

- 11.1 Scoring will be as per GCR's. i.e. 25 points will be allocated to the overall 1st place at the end of each meeting, 22 pts for 2nd place, 20 pts for 3rd place, 18 points for 4th place, 16 points for 5th place, etc,
- 11.2 Results will remain "Provisional" until ratified and confirmed by Motorcycling NSW.
- 11.3 If the meeting is a Championship, all championship classes will take precedence over support classes.

12. MACHINES AND RIDERS:

- 12.1 All machines entered must comply with the current GCR's for Classic Dirt Track competition.
- 12.2 Multiple entry of the one machine in the same class of competition is not permitted.
- 12.3 There will be no change of machines once the competition has commenced.

12.4 Noise &/or Fuel Testing may be carried out at any time during this meeting.

13. <u>RIDING NUMBERS:</u>

- 13.1 Competitors will be allocated their Motorcycling NSW Registered Riding Number or their preferred riding number if available. All others shall be allocated numbers at the PROMOTER'S discretion.
- 13.2 All number plates on all machines MUST comply with the GCR's.

14. GRID POSITIONS:

- 14.1. Grid Positions will be predetermined and assigned as per the program.
- 14.2. Grid positions for the repechage/finals will be chosen by the highest point scorer having first choice and so on.
- 14.3. If any rider does not start their race in the correct grid position, they will be excluded from that race.

15. <u>RIDERS BRIEFING:</u>

A Riders' briefing will be held prior to the commencement of practice and all participants MUST attend. Riders' briefing sign-on sheets must be signed by the competitor as confirmation of attendance.

16. DRUG AND OR ALCOHOL TESTING:

By order of Motorcycling NSW, random drug &/or alcohol testing of participants (i.e. officials, competitors, mechanics, pit crew and any other person associated with the control, direction and operation of the competition) may take place prior to, or at any time during this meeting.

17. <u>CODE OF CONDUCT:</u>

All participants, officials and parents are reminded of the Motorcycling Australia - CODE OF CONDUCT (as stipulated in the GCR's) which is a guide to appropriate behaviour at all motorcycle race meetings. This CODE OF CONDUCT applies to this meeting and shall be enforced.

For the purposes of drug & alcohol testing, the commencement of the meeting will be deemed to be opened when the gates open at 7:30am with the completion of the meeting for the participant being at the completion of racing.

19. <u>CIRCUIT DESCRIPTION:</u>

The circuit is approximately 760 metres in length: the surface is of loose granite construction, rolled and watered. Racing will be in an anti-clockwise direction.

20. <u>STARTS:</u>

All starts will be drop forward gates with a maximum of 12 Solos. If a rider jumps the gate they will be excluded, and the event will be re-started. No rolling starts. Starts may revert to rubber band starts.

21. <u>RACING:</u>

Practice will be 2 laps per class of machine, heats if applicable are 3 laps and finals 4 laps. The finish line is on the main back straight.
