A nomination in any category can be completed by any member of a Motorcycling NSW Club.

## HOW TO SUBMIT YOUR NOMINATION

We realise it is difficult to summarise the service, contribution and achievements of our nominees who do what they do often without recognition. While there is no minimum or maximum word count, MNSW encourages you to provide the judging panel with sufficient accurate and relevant information on your nominee.

## HOW WILL THEY BE RECOGNISED

The prestige of the Award is the most valuable aspect of the Motorcycling NSW Awards, recognising the outstanding contribution during the judging period. All finalists will receive a certificate acknowledging their status as a 'finalist'.

Winners will also be presented with a MNSW plaque and promoted via our communication channels highlighting the specific award winner. The award recipients as well as their Clubs are encouraged to engage local media to further leverage opportunities for community partnerships and recognition.

Furthermore, MNSW will elevate State winners for external recognition where appropriate. This may include Sport NSW or other industry awards. Please note, this is at the discretion of MNSW and some nominations may require further information.

Key Criteria: This prestigious-award is bestowed upon a member recognising an outstanding volunteer who has gone above and beyond to make a significant contribution to Motorcycling in NSW.

- Be a current financial member of MNSW

*N.B Nominees do not have to be involved at all levels*

- Unpaid Position (Honorariums & Hobby Payments Accepted)
- Active in a volunteer only role within the Club or Discipline (MNSW or MA)
- Can be involved in any capacity of the Club or Discipline (MNSW or MA)
- Individuals can only receive one Community Club Award

*N.B Nominees do not have to be involved at all levels*

##### **2. SERVICE**

- Provide summary of the nominee's roles/service to the sport.

*NB. Each club is eligible for a maximum of one recipient per year.*

## **DISTINGUISHED SERVICES AWARD**

A Club/Discipline can only nominate one person for this prestige award. A Distinguished Service Award can only be received once, and no more than 6 will be awarded annually.

- Must have completed 20 years continuous service at either Club/Discipline/State level
- Not a MNSW or MA Life Member.

This award recognises a Motorcycle Club for overall excellence in administration, operations and event success during the period. This award pays particular attention to strategies, projects, programs and innovation which enhance and support participation growth in Riders, Officials and coaching representing the 'best in class'.

The judging period between 1 NOVEMBER 2023 – 1 OCTOBER 2024.

### **NOMINATE HERE**

#### **CRITERIA:**

##### **1. ELIGIBILITY**

- Must have a valid social media account that creates and shares content on the sport of Motorcycling and has been active during the judging period
- Whilst the size of the nominee's online community is important it will not be the sole basis on which the award will be judged. Content that shines a positive light on our sport and Motorcycling community will be paramount in the selection of the winner.

##### **2. ENGAGEMENT**

- Demonstrate how your content was key in successfully driving positive interaction with the members
- Use of platforms
- Share content consistently
- Drives positive interactions with members through posts
- Displays up to date information on Club operations
- Shares a variety of posts e.g., videos, polls, images, reels etc.

##### **3. CREATIVITY/INNOVATION**

- Describe any social media innovation that have improved engagement with your online Motorcycling community
- Describe any social media activation that have contributed to the growth of participation within your club

##### **4. ADDITIONAL INFORMATION SUPPORTING THIS NOMINATION**

## COMMUNITY CLUB EVENT OF THE YEAR

This award recognises an exceptional Club event that provided positive engagement of community and participants. The recipient will have delivered positive promotion of the sport to gain exceptional engagement with their community and the greater participation among the Motorcycling community.

The judging period between 1 NOVEMBER 2023 – 1 OCTOBER 2024.

### [NOMINATE HERE](#)

#### CRITERIA:

##### 1. ELIGIBILITY

- The host must be an affiliated Motorcycling NSW Club.
- The event must have been held during the eligibility period.
- The event must have been hosted in NSW
- The event must have been permitted by Motorcycling NSW and have been permitted through the Ridernet system.

##### 2. ENGAGEMENT

- Demonstrate how the event was key in successfully driving positive interaction with the members & community
- Growth in localised participation
- Positively promoted Motorcycling Sport
- Engaged with other Key stakeholders within the local community (i.e., Local Council, Community groups or local businesses)
- Successful promotion of the event using platforms such as social media
- Point of difference for the event that sets it side from other events being held during the eligibility period.

##### 3. ADDITIONAL INFORMATION SUPPORTING THIS NOMINATION

## **FACILITY/VENUE DEVELOPMENT OF THE YEAR**

The award aims to promote and celebrate the provision of well positioned, welcoming, accessible, fit for purpose motorcycling facilities that support our sports requirements.

The judging period between 1 NOVEMBER 2023 – 1 OCTOBER 2024.

### **NOMINATE HERE**

#### **1. ELIGIBILITY**

To be eligible, the facility must be related to community level Motorcycling in NSW. The facility must have links to and/or benefit a community motorcycling club in NSW.

#### **2. CRITERIA**

- The facility should deliver one or more of the following priorities:
  - Facilities meets the needs of our Motorcycling community through the provision of inclusive and accessible amenities, changerooms, and welcoming functionality that enhance spectator experience.
  - Venue capacity is maximised by improving quality of tracks and supporting infrastructure.
  - Growing communities have access to quality Motorcycling facilities and support the development of and access to tracks.
  - Facility/Venue supports talent pathways and competition growth for riders, officials and volunteers.

#### **3. ADDITIONAL INFORMATION SUPPORTING THIS NOMINATION**



## OFFICIAL OF THE YEAR

This award recognises an official who consistently displays both outstanding personal attributes, administrative skills and education within our motorcycling community. Officials include, Stewards, Clerk of Course, Race Secretary, Scrutineers and Coaches.

The judging period between 1 NOVEMBER 2023 – 1 OCTOBER 2024.

### [NOMINATE HERE](#)

#### CRITERIA:

Taken into consideration will be all motorcycling events that the individual participated in as an official during the eligibility period.

#### 1. ELIGIBILITY

- Must be a current MA licence holder
- Must be a current financial member of an MNSW affiliated Club.
- Must have officiated at a Motorcycling NSW permitted event during the eligibility period. or
- Conducted Coaching programs with Motorcycling NSW Clubs

#### 2. PERSONAL VALUES

- Consistently displays a positive attitude and passion for motorcycling.
- Outstanding interpersonal skills
- Has a service mindset
- Is fair, honest & courteous when interacting with riders, officials and other volunteers.

#### 3. PERFORMANCE

- Has a thorough understanding of the general competition rules abiding to the discipline/s that they officiate within
- Is fair & courteous when interacting with riders, volunteers and other officials
- Is organised and completes all required tasks required of them including all paperwork and notifications to riders, community and Motorcycling NSW published, completed or submitted accurately and on time.
- Runs events/programs consistently to schedule
- Prioritises compliance, education and positive rider experience above all else.
- Encourages riders and displays the attributes of an excellent role model at all times.
- Encourages other members of the community to participate as a volunteer or official.
- Or provides excellent outcomes for clubs and riders through their coaching programs.

## COACH OF THE YEAR

This award recognises Coach who consistently displays both outstanding personal attributes, administrative skills and education within our motorcycling community.

The judging period between 1 NOVEMBER 2023 – 1 OCTOBER 2024.

Taken into consideration will be all motorcycling events that the individual participated in as a Coach during the eligibility period.

- Must be a current MA licence holder/Accredited Coach
- Must be a current financial member of an MNSW affiliated Club.
- Conducted Coaching programs with Motorcycling NSW Clubs during the eligibility period

#### 2. PERSONAL VALUES

- Consistently displays a positive attitude and passion for motorcycling.
- Outstanding interpersonal skills
- Has a service mindset
- Is fair, honest & courteous when interacting with riders, other coaches, officials and other volunteers.

#### 3. PERFORMANCE

- Has a thorough understanding of the general competition rules abiding to the discipline/s that they Coach within
- Is fair & courteous when interacting with riders, other coaches, volunteers and other officials
- Is organised and completes all required tasks required of them including all paperwork and notifications to riders, community and Motorcycling NSW published, completed or submitted accurately and on time.
- Runs events/programs consistently to schedule and in alignment of permit conditions
- Prioritises compliance, education and positive rider experience above all else.
- Encourages riders and displays the attributes of an excellent role model at all times.
- Encourages other members of the community to participate as a volunteer, coach or official.
- Or provides excellent outcomes for clubs and riders through their coaching programs.

# Performance Awards

## HALL OF FAME

This award recognises an individual's extraordinary performance over a career by riders and special members who have achieved at the highest level within their discipline across State, National and International levels.

### [NOMINATE HERE](#)

#### CRITERIA:

##### 1. ELIGIBILITY FOR COMPETITOR MEMBERS

- Must be an Australian Citizen or Resident or have held a competition licence issued by MA and MNSW Body for a significant period of time;
- Have commenced riding/competitive journey with a current or previously affiliated MNSW Club;
- Be a superior achiever at the highest level of competition in their chosen discipline;
- Have participated in a discipline which is one of national or international significance;
- Potential inductees shall not be considered until after at least a two-year waiting period following retirement from their highest level of competition in a particular discipline; or the performance of a particularly outstanding achievement that warrants special recognition or where in the relevant discipline, age is not a barrier to continued competition.

##### 2. ELIGIBILITY FOR SPECIAL MEMBERS

- For consideration in this category, a potential inductee must have achieved great success as either a team principal or manager, technical or engineering innovator, at the very highest level either for their state, nationally or internationally.
- The potential inductee must have made a very significant contribution to motorcycling sport at the state, international or national level.
- Potential inductees may also have been competitors or have been involved in other areas of motorcycle sport, but their achievements must satisfy the criterion detailed in point number 1 above.
- Irrespective of their area of involvement, potential inductees must have been committed to the development of the sport, have contributed to motorcycling sport at the highest level either nationally or internationally, and risen to the highest level possible within their chosen field.
- Long service is not sufficient on its own to qualify a person as a potential inductee.

## RIDER OF THE YEAR – EACH DISCIPLINE

This award recognises a rider who consistently displays both outstanding personal attributes and performance within our motorcycling community within their discipline.

### CRITERIA:

This award is based on the accomplishments of the individual in respect to his/her overall results. Taken into consideration will be all motorcycling events that the individual participated in at a competitive level.

#### 1. ELIGIBILITY

- Must be a current MA licence holder.
- Must be a current financial member of an MNSW affiliated Club.
- Must have ridden at a club level.
- Must meet the age eligibility for their category
- Must have ridden at the relative MNSW Discipline State Championship or series – where applicable
- Must have ridden at the relative MA Discipline National Championship or series – where applicable

#### 2. PERSONAL VALUES

- Consistently displays a positive attitude
- Is fair & courteous when interacting with peers, officials and other volunteers.
- Encourages other riders and displays the attributes of an excellent role model at all times

### 3. PERFORMANCE

Has consistently and repeatedly achieved podium positions;

- in any club level series or event,
- interclub event or series
- open event or series

N.B for the purpose of this criteria podium refers to 1<sup>st</sup>, 2<sup>nd</sup>, 3<sup>rd</sup>, 4<sup>th</sup>, or 5<sup>th</sup> placings.
