#### **MOTORCYCLING NSW POLICY GUIDELINES FOR ISSUING OF PERMITS**

Authority: This document is a policy made pursuant to the Motorcycling NSW Constitution. MNSW may

unilaterally introduce, vary, remove or replace this policy at any time.









# 1. Policy

This policy is to be utilised in conjunction with the General Competition Rules listed within the Manual of Motorcycle Sports, the MNSW Permit Conditions, MA & MNSW Product Guidelines and the MNSW by-laws.

- **1.1.** Issuing of permits for competition meetings that clash with similar type meeting will be determined based on the following conditions (subject to only competition meetings, other meetings such as schools, recreational etc. are not covered by this policy):
  - **1.1.1.** No competition meeting of the same or similar discipline will be permitted on the same weekend as an MNSW State Title meeting; unless the MNSW State Titles meeting is allocated after the open calendar has been approved and published.
  - **1.1.2.** No competition or recreational permits will be permitted for State Titles venues within 8 days of the scheduled start date of that permit.

#### 2. Events

### 2.1. Open Events

- **2.1.1.** MNSW will issue competition permits upon application to all meetings outlined on the MNSW open calendar after the relevant Sports Committee has provided approval of the supp regs and the calendar has been published by MNSW.
- **2.1.2.** An open competition meeting will only be permitted in conflict to those listed on the MNSW open calendar of the same or similar discipline if it is not within 300kms (by road) of the event listed on the calendar or if the original host of the competition listed on the calendar grants written permission.

#### 2.2. Club Events

- **2.2.1.** No restrictions on closed to club meetings of the same or similar discipline will occur if they clash with other club events of the same or similar disciplines.
- **2.2.2.** It is expected that clubs within proximity work in partnership and manage calendars to avoid conflicts.
- **2.2.3.** Clubs and promoters are eligible to provide a written submission to the CEO if a valid reason exists to approve a meeting that does not comply with the above conditions. The CEO will have the final decision.

#### 2.3. Conflicts & Resolutions

- **2.3.1.** The CEO will determine if an event is of the same or similar discipline and if the meeting conflicts with another dependent on date and venues of the proposed meetings.
- **2.3.2.** If a club has a concern about conflict, authorised representatives of the club must present their concern in writing to MNSW to determine if any breach of policy exists.

## 3. Rationale

By creating a standard policy of competition events, which will be permitted, enables clubs and officials to organise their events without the possibility of competition from surrounding clubs. It also enables riders to participate at meetings without affecting their participation in other competitions or point scores.
