1. ANNOUNCEMENT

Motorcycling MNSW, and the NSW Minikhana Clubs hereafter referred to as the Promoters, will conduct the 2025 NSW Minikhana State Championship Series, 5-round Minikhana Series at the venues and dates listed below.

2. JURISDICTION

- 2.1 The abovementioned meeting has been authorised by Motorcycling NSW which has issued the Motorcycling Australia Permit Number **as per above** and is open to holders of current Motorcycling Australia MA Junior (JNA), (JNR), (MINI) National Licences.
- 2.2 The meeting will be held in accordance with the current 2025 General Competition Rules (GCRs) contained in the Manual of Motorcycle Sport, these Supplementary Regulations, and any final instructions approved by Motorcycling NSW. By entering this meeting all parties agree to comply with these rules, regulations, by-laws and instructions.
- 2.3 Age requirement: The age of the Junior rider will be determined by the age the rider is at the 1st of January; Competitors may choose to move up to an older age group after their birthday.

4. ENTRIES

- 4.1 Entries are now open via Ridernet, and will close on the designated date on the permit. On the day entries will not be accepted.
- 4.2 In the case of postponement or abandonment of the meeting, all or any part of the entry fee may be retained by the Host Club, if such retention is approved by Motorcycling NSW.
- 4.3 Entry fees will only be refunded if a rider informs the Race Secretary, in writing, 2 days before the event. A medical certificate is required if a rider withdraws less than 1 day before the event.

6. ENTRY PASSES

6.1 N/A – Entry is included in Entry Fees, Spectators are Free.

7. INSURANCE

- 7.1 Those who hold an MA licence current for the duration of the Event, and officials, who are signed on for the Event are covered by MA's National Personal Accident Scheme which provides basic cover for rehabilitation expenses and death and permanent disability benefits. For more information see Insurance Motorcycling Australia (ma.org.au).
- 7.2 Ambulance Insurance is compulsory for licensees. It is strongly recommended that competitors give consideration to taking out weekly benefits insurance.

8. MEDICAL SERVICES

examined before participating again.

- 8.1 Professional Medical personnel will be in attendance from commencement of practice to completion of racing at all 5 rounds.
- 8.2 All medical information is kept strictly private and confidential and will only be made available to medical personnel if they are required.
- 8.3 First aid MUST be accepted wherever deemed necessary by the attending medical personnel.
- 8.4 The Steward and/or Clerk of Course has the right to refuse further racing of a rider if first aid requirements are not adhered to.

9. TECHNICAL INSPECTIONS (PREVIOUSLY KNOWN AS SCRUTINEERING)

- 9.1 Technical inspections (Scrutineering) for competitors will be conducted prior to the start of the event.
- 9.2 The onus of proving that a competitor, and the competitor's machine and protective clothing/ equipment, are eligible to compete, is on the person seeking to prove it. Full riding gear (boots, helmet, armor etc.) must be worn. Eligibility checks can take place at any time during the meeting. Machines which suffer accident damage in practice or race sessions must be

10.1 Juniors wishing to participate in any class MUST have a suitably endorsed licence, if not, the junior rider is INELIGIBLE to compete in that chosen class.

11. ENTRIES TO CONSTITUTE A CLASS

- 11.1 To constitute a class for the purpose of gaining Championship status, the number of contestants entered and competing in each class shall be $\underline{\mathbf{4}}$.
- 11.2 Should there be insufficient entries in any class of competition, the decision to run or cancel the class, or to combine events and re-distribute any awards and/or prizemoney, will be at the discretion of the Host Club, subject to Motorcycling NSW approval.
- 11.3 As per GCR 16.3.1.6 A competitor may be instructed to move up a grade temporarily by the SCB Grading Officer in the case of an Inter-Club or Championship Event.

12. STARTS AND FINISHES

Minikhana events - Flag start.

Minicross - Self-penalizing backward-falling gates and Bungee Cord.

Minicross Start Procedure:

- 1. A 15-second board will be displayed to all riders.
- 2. The 15-second board will then be turned sideways or reversed to display the 5-second board.





- 3. After this, the gates/bungee cord will drop at any point within 10 seconds.
- 4. The race will finish when the chequered flag is displayed. Competitors must race to the chequered flag.

13. FLAGS AND SIGNALS

- 13.1 Yellow flag waved Great danger, prepare to stop, no overtaking. A significant reduction in speed must be observed; therefore, jumps should not be attempted.
- 13.2 During the first lap of practice, yellow flags will be stationary indicating there will be no jumping. The yellow flag will be waived if there is an incident on track.
- 13.3 The chequered flag indicates the race finish and must be displayed to each competitor as each crosses the line, with the flag being displayed to the first competitor to complete the race, and thereafter to each competitor who has completed. All Riders must ride to the checkered flag.
- 13.4 A green flag indicates that the track is clear, and racing can proceed.
- 13.5 When the red flag is displayed, riders must return to the pit area and wait further instructions from the Clerk of the Course.
- 13.6 Minikhana Events When the black flag is displayed to a competitor, that rider is disqualified and must remain stationary on the course, until the final competitor has completed the event and the penciller has signaled the events completion, in the event of Minicross the rider must return to the pits and take no further part in the race.
- 13.7 The purple flag held up by a junior competitor indicates an intent to protest.

14. RACE FORMAT

- 14.1 The NSW Minikhana State Championship will consist of five rounds. Championship standings are determined by the total points accumulated across all rounds, with Championship status awarded to the 1st, 2nd and 3rd podium finishers in each class.
- 14.2 In addition, each round will be a standalone event with its own trophies/plaques and presentation.
- 14.3 Each round will be scored as per below and as per the GCR's for Minikhana **Section Number 16.17.2 Scoring**

15.1 For the purposes of drug and alcohol testing, the commencement of the meeting will be deemed to be 6.30am with the completion of the meeting for the participant being when the participant has vacated the venue.

16. AWARDS AND PRIZEMONEY

16.1 State Rounds (Rounds 1,2,3,4,5)

All Demo/Nipper riders will receive an award for their participation.

Competition classes:

Medals will be given for 1st, 2nd and 3rd place in each event.

Overall class grade winners will receive a trophy for 1st, 2nd and 3rd places.

The State Championship series awards will be presented at Round 5 Sunday 19th October, to the 1st, 2nd and 3rd placegetters in each class.

16.2 It is the rider's responsibility to collect or arrange collection of their awards.

17. PRESENTATIONS

- 17.1 Round presentations will be held after the completion of racing of all classes at each round of the series.
- 17.2 The State Championship series presentation will be held after the round 5 presentation at the final round of the series.





18. MACHINES AND RIDERS

- 18.1 All machines entered must comply with the current GCRs for Minikhana competition.
- 18.2 Multiple entries of the one machine in the same class of competition is not permitted.

19. RIDING NUMBERS

- 19.1 All number plates on all machines MUST comply with the GCRs and must be of contrasting colours, background to numbers.
- 19.2 Riding numbers MUST accompany your entry in Ridernet, prefixed with your club acronym e.g. JT100, BT100, H100, P100.

20. GRID POSITIONS

20.1 By random draw of discs.

21. RIDERS' BRIEFING

- 21.1 A riders' briefing will be held prior to the commencement of the event, which ALL competitors MUST attend.
- 21.2 Junior competitors MUST have a parent or guardian in attendance.
- 21.3 The Clerk of Course may at his/her discretion penalise any competitor who is not present at rider's briefing and is proven not to be in attendance by not scanning in prior.
- 21.4 Smoking and Vaping (e-cigarettes) is strictly prohibited at Riders Briefing. Smoking Rules as per government laws NO Smoking at junior sporting events.
- 21.5 Details will be included in the final instructions.

22. TRACK INSPECTION

22.1 All competitors will be given the opportunity to walk and inspect the track prior to any on track participation. This inspection must be done on foot and competitors are reminded that service vehicles may be in operation on the circuit at this time.

22.2 Track Dissatisfaction

Competitors who are not satisfied with any aspects of the track can present these concerns to the Clerk of Course. If those concerns cannot be resolved, the competitor will be invited to withdraw from the meeting.





23. FACILITIES

- 23.1 Toilets will be available at each round.
- 23.2 Canteen Facilities will operate at each round by the hosting club, Eftpos will be available.
- 23.3 Any additional facilities will be listed in the final instructions for each round of the series.

24. NOISE

24.1 Noise testing may take place at any time at the discretion of the Chief Technical Inspector or the Clerk of Course. Refer to GCRs Minikhana chapter for details.

25. ANTI-DOPING POLICY

- 25.1 All competitors, crew, parents/guardians and officials are advised that drug testing may take place in accordance with MA's Anti-Doping Policy, under the authority of Sport Integrity Australia.
- 25.2 If any doubts exist over banned substances, it is recommended competitors contact the Safe Sport Hotline, ph.: 1800 161 361 7am 7pm AEST 7 days a week/365 days a year.

26. DRUG AND ALCOHOL TESTING

All competitors and officials are advised that random drug and alcohol testing may take place during the competition. Refer to MA website for details on the Safety Policy – Drug and Alcohol testing.

27. CODES OF BEHAVIOUR

27.1 All competitors, officials and parents are reminded of MA's zero tolerance of poor behaviour, either on

or off track. The codification of the behaviours expected of MA members and all who attend or participate in motorcycling is contained within MA's policies, including its Member Welfare Policy and its social media Policy, which can be found at Policies - <u>Motorcycling Australia (ma.org.au)</u>.

28. FIRE EXTINGUISHERS

- 28.1 All riders must have a minimum 2kg, **dry powder A:B (E) class**, working fire extinguisher in their pit area.
- 28.2 Riders with electric bikes must have an **F-500 fire extinguisher**, specifically designed for lithiumion battery fires.

29. ELECTRONIC COMMUNICATIONS AND SOCIAL MEDIA

29.1 All competitors, officials and parents are bound by of MA's Social Media Policy, found at www.ma.org.au, which sets out a framework for acceptable online behavior where communications involve fellow MA members, volunteers, officials, coaches, sponsors, partners, staff and any other connected persons, penalties may apply for breaches of the policy.





30. ADMISSION CHARGES

30.1 Entry is free for all spectators.

31. ENVIRONMENTAL RESPONSIBILITY

31.1 All riders are responsible for the removal of all items including rubbish from their camping and pit areas as they vacate the premises. Penalties may apply as per GCR's – Manual of Motorcycle Sport.

32. DISCIPLINE SPECIFIC INFORMATION

32.1 Any protest must

- a) Be in writing.
- b) Be accompanied by the prescribed fee of \$100 plus the applicable bond under 2025 Manual of Motorsports (MoMS) GCR 5.1.7 where the protest involves the measurement of an engine or component of an engine, which will be refunded if the protest is upheld.
- c) Be received by the Clerk of Course and conveyed to the Steward;
- d) Comply with the following time limits:
 - i) For a protest under sub-Rules a) and b) of the previous GCR, thirty (30) minutes after being informed of the decision;
- ii) For a protest under sub-Rule c) of the previous GCR being within thirty (30) minutes of such action or conduct.
- 32.2 The following additional requirements apply to all competitors who are under the age of 16 years and seeking to protest the action or conduct of any other competitor, Official or Support Person during Competition:
 - a) A protest may only be made by a competitor;
 - b) The competitor must indicate the intent to protest to an Official prior to returning to the pits;
 - c) The Clerk of Course must designate an area, to be announced at the riders' briefing and to be marked by a purple flag, where an Official must be present to note any indications of protest;
 - d) No discussion on the content of the protest may take place at the marked position; and
 - e) A competitor who indicates an intent to protest must return to the pits and present the protest to the Clerk of Course within the time limits referred to in the previous rule.

Protest process for on the day of the event;

- (i) There will be a purple flag at each event area. Competitors are to raise the purple flag without instruction or interference from a parent/guardian or other, this shows their intent to protest.
- ii) The penciller will then assist the competitor fill out the official MA protest form with the rider's name.
- iii) The competitor can then return to the pits, seek their parent or guardian to fill in the form and endorse their protest with the \$100 fee.
- iiii) The competitor then presents the protest to the clerk of course.

32.3 Restrictions

- a) Body jewelry is to be removed or securely covered with tape prior to the competition.
- b) Hair longer than shoulder length must be confined in the helmet or clothing.
- c) No hooded jumpers or jackets to be worn at any time whilst competing.





- 32.4 Marshals Each rider must supply a marshal. 2x riders = 2x marshals, and so on.
- 32.5 Name of the people responsible for the rider will be pre-drawn for marshalling duties.
- 32.6 The carrying or consumption of alcoholic beverages in the pit areas is prohibited, by order Motorcycling Australia Ltd Notice 4.3
- 32.7 There is **NO** dogs allowed at any round with exception to Guide Dog and Assistance Animals excepted, by order Motorcycling Australia Ltd Notice 4.4
- 32.8 Enclosed footwear must be always worn. There are no thongs and no Crocs allowed.
- 32.9 No persons under 16yrs of age allowed in pit and event areas, unless they are a competitor.
- 33.0 No Smoking and Vaping (e-cigarettes) allowed. Smoking Rules as per government laws – NO Smoking/Vaping at junior sporting events.
